YOU ARE INVITED to join us February 7th & 8th 2009 for VARA's **Pre-Season Test & Tune Days** This will be held in conjunction with the two day University of VARA at **Buttonwillow Raceway Park**. A great opportunity to make sure your car is in tip top shape for VARA's Season opener to be held at Auto Club Speedway March 6th-8th 2009. The test sessions will be open and closed wheel sessions and we will be running the East loop, the West loop and the entire track at different times throughout the weekend. This will also be exciting for the University students to see some great vintage cars. In addition to the test and tune sessions we will have a wine and cheese gathering on Saturday night for the testers and the students.

TEST AND TUNE ENTRY INFORMATION

The entry fee for the two days of testing is only \$150.00. There will be a schedule for open and closed wheel cars on different areas of the track throughout the weekend. One of the great things about Buttonwillow Raceway Park is that it offers different track configurations. This will be an opportunity for you to test on some new ones. Entries received after January 30th will be required to pay a \$35.00 late fee. No Gate passes will be mailed with your acceptance package. Buttonwillow Raceway Park requires each person entering the gate to pay a \$10.00 admission fee which is good for the weekend.

Registration will begin at the track Friday afternoon beginning at 3:00pm and resume Saturday morning at 7:00am.

Timing And Scoring- We will not have timing and scoring for the test sessions.

Requirements for Testing

Testing is available for competition licensed drivers only. Unlicensed drivers should attend the University. Testing is also only available to race prepared cars with all the proper safety equipment for car and driver.
