Minimum safety requirements for street registered and driven cars:

- ✓ Must have factory installed or DOT approved seat belts / shoulder harness.
- ✓ Cars must be mechanically sound with no fluid leaks.
- ✓ All open cars convertibles must have roll bar protection subject to review by VARA technical inspection.
- ✓ Drivers must have a helmet with a Snell rating tag adhered to the inside of the helmet of, M2010, SA2010 or newer. No earlier helmet Snell certification dates or non-Snell rated helmets are acceptable. Full face designed helmets are highly recommended. Without exception, open face helmet wearers must use shatterproof goggles or wrap around style shatterproof sport glasses, however, open face helmets will only be allowed in enclosed street vehicles.*
- ✓ Drivers must have a long sleeve heavy shirt or jacket and long pants. Leather gloves or fireproof driving gloves and strongly recommended and are considered mandatory in a convertible / open cockpit cars for this event.

Minimum safety requirements for Race Prepared Cars:

Car and driver must have in their possession and utilize <u>ALL</u> required safety equipment as specified in VARA safety regulations. For additional information regarding these requirements, please refer to the 2015 VARA RULE BOOK, Section A: Driver Safety and Licensing, Subsections A.2 though A.5 as well as TECH RULES & CAR CLASSIFICATION, Section H.
